Personal Accrued Time	Check your accrued time-off balances as of the last payroll cycle. Note: This activity is available only if your organization uses the Time Off feature.
Annual Statements	View available W-2, W-2C, and 1099 annual wage and tax statements. Note: Tax forms remain online for three years.
Calculators	Access various financial tools. (See the Employment Profile information for details.)
Direct Deposit	Set up and maintain accounts into which you want direct deposit.
Tax Withholdings	<ul style="list-style-type: none"> View your federal, state, and local (if applicable) tax withholdings. Change your federal tax withholdings. Access tools to help you estimate important financial calculations. Note: If you find an error with your state or local tax withholdings, or you wish to make a change, notify your payroll or human resources representative.
Pay Statements	<ul style="list-style-type: none"> Access your pay statements. Download the ADP Mobile app.

My Time Entry	Clock in and out.
My Timecard	<ul style="list-style-type: none"> Review your timecard. Based on your organization's setup, you may be able to do the following: <ul style="list-style-type: none"> Correct entries. Enter missing time. Approve your timecard.
Schedule at a Glance	View your schedule for the next seven calendar days.
Actual vs Scheduled	View your actual hours worked compared to your scheduled hours.
Monthly Schedule	View past, present, and future schedules of a month-long period.
Annual Summary	View a one-year summary of your time and attendance.
Holiday List	View your organization's list of observed holidays.
Attendance	View your attendance record for a specified period of time.

- The Time & Attendance submenu is available only if your organization uses this feature.
 - The information that you see and the actions that you can perform may vary based on how your organization defined the feature during implementation.

Access your benefits statement. View the plans for which you waived enrollment. Review your benefits compensation (used to calculate benefit amounts for certain plans for which you may be eligible and enrolled in).
Employee Discounts	<p>Access LifeMart's website for employee discounts.</p> <p>Note: This activity is available only if your organization uses LifeMart.</p>
COBRA	<p>Access ADP's COBRA website.</p> <p>Note: This activity is available only if your organization uses ADP's COBRA service.</p>
Spending Accounts	<p>Access ADP's FlexDirect website.</p> <p>Note: This activity is available only if your organization uses ADP's Spending Account service.</p>
